The Town Board of the Town of Lee, New York, pursuant to its home rule authority, hereby amends Sections 267(11) and 271(15) of the Town Law of the State of New York, such that the Town Board hereby establishes alternate Zoning Board of Appeals member positions and alternate Planning Board member positions for the purposes of substituting for a regular member in the event such regular member is unable to participate because of a conflict of interest, illness or other absence, regardless of whether or not the same is necessary to constitute a quorum.

Alternate members shall be appointed by Resolution of the Town Board for terms established by the Town Board.

When so designated, such alternate member shall possess all the powers and responsibilities of a regular member of said Board.




