

Town of Lee "Town Dump Ordinance"

Pursuant to authority conferred upon Towns by Section 130 and 135 of the Town Law and other laws of the State of New York empowering them to enact ordinances, the Town Board of the Town of Lee does hereby enact and ordain the following ordinance:

ARTICLE I

"Title"

This ordinance shall be known as the "Town Dump Ordinance"

ARTICLE II

"Purpose"

The purpose of this ordinance is to prohibit and/or regulate the use of any lands within the Town of Lee which are or which may be designated as Town of Lee Public Dumping Grounds and to provide penalties for violations of such regulations.

ARTICLE III

"Definitions"

The term "Town Dump" as used in this ordinance shall be defined as any lands within the Town of Lee which are owned or leased and maintained by and for the use of residents of the Town of Lee as subject to the provisions of this ordinance.

The term "Person" as used in this ordinance shall be defined to include any person, firm or corporation.

The term "Town Board" as used in this ordinance shall be defined to mean the Town Board of the Town of Lee.

ARTICLE IV

"Regulations"

Section 1. It shall be unlawful for any person not actually or temporarily residing in the Town of Lee, or any firm or corporation not actually located in the Town of Lee to use the Town Dump for any purpose whatsoever.

Section 2. It shall be unlawful for any person to place, deposit or dump any garbage, dead animal or other thing of an unwholesome, odorous or otherwise objectionable nature in the Town Dump.

Section 3. It shall be unlawful for any person to place, deposit or dump any paper or other loose or combustible materials, which may be subject to being carried away by the winds in the Town Dump, unless such materials are tied or otherwise contained to prevent their being carried by the winds.

Section 4. It shall be unlawful for any person to place, deposit or dump anything of any nature in any stream in the Town Dump or in the roadway or outside the fences adjacent to the Town Dump except where indicated by signs or other directive.

Section 5. It shall be unlawful for any person to damage or destroy any sign, fence, tree or other property in or upon the Town Dump in any manner, and it shall be unlawful for any person to discharge any firearm upon or into such Town Dump.

Section 6. It shall be unlawful for any person to enter upon or from a place adjacent to the Town Dump, and pick over, scatter, carry away or otherwise disturb any material or thing in such Town Dump. This shall not apply to any person engaged in maintenance or work in such Town Dump when ordered or authorized by the Town Board.

ARTICLE V

"Penalties"

Any person, firm or corporation who violates any provision of Article IV of this ordinance shall be guilty of a misdemeanor.

ARTICLE VI

"Constitutionality"

If any section, paragraph or subdivision or provision of this ordinance shall be invalid, or held unconstitutional, such invalidity shall apply only to the section, paragraph, subdivision or provision adjudged invalid and the rest of this ordinance shall remain valid and effective.

ARTICLE VII

"Time To Take Effect"

This ordinance shall take effect immediately after its adoption and approval by the Town Board and upon compliance with the provisions of Section 133 of the Town Law.
